TRACKING THE PROGRESS OF THE MINECONOMY'S STRATEGIC PROJECTS

We started to implement a project-based approach

Group Economic Recovery and Development. The status of the Recovery Plan implementation for 6 months has been monitored. The Deputy Ministers were assisted in preparing analytical materials, investment projects, and presentations for the URC-2023 conference in London.



OF STATE-OWNED ENTERPRISES The Mineconomy was assisted in the formation of supervisory boards of the GTS operator and EnergoAtom. We advised on amendments to the relevant industry-specific resolutions, including

REFORM OF CORPORATE GOVERNANCE

No. 777 on strengthening the process of selecting independent members of supervisory boards and senior management for the largest state-owned enterprises. The charters of 10 state-owned enterprises have been updated. Jointly with the Mineconomy, we participated in the preparation of the draft law No. 5593-д text, which was submitted to the industry-specific committee of the VRU. The corporate governance reform applies to 3500 state-owned enterprises and 85% of the revenue they generate. Representatives of the EBRD, the IMF, the European Commission, and the

G7 countries participated in the reform development process.

The design of a grant program to support men and women veterans and their families was developed. This program resulted in 76 grants for UAH 23.8 mln for men and women veterans and 60 grants for UAH 30.2 mln for the second spouse. A concept for a

DEVELOPMENT OF THE CONCEPT OF APPROACH TO THE SELECTION OF



We provided proposals for transforming the approach to the selection of educational areas of state-funded training, which the state annually finances for about UAH 47.5 bln. A medium-term labor market forecast for the formation of the state order for 2024 with consideration of current economic needs and challenges has been developed.

EDUCATIONAL AREAS OF STATE ORDER

PROCESSES OF THE STATE EXPORT CONTROL SERVICE We assisted in restructuring the State Export Control Service of Ukraine with changes in leadership approaches and business processes. As a result, the review period for import applications was reduced to 5-7 days, instead of 15.

Following the project, the loyalty index of external stakeholders to the State Export Control Service (NPS) increased from –15% in June

Proposals have been made to amend the Law on Public Procurement to allow physical entities/individual entrepreneurs

COST CONSIDERATION METHOD IN PUBLIC PROCUREMENT (LCC) Four pilot procurements using the Life Cycle Cost Assessment

Method have been carried out for Ukrposhta, Ukrenergo, Ukrzaliznytsia, and the Patrol Police for a total contract amount of UAH 877 thousand. We developed two intensive courses and created a training course on the method, which was attended by about 400

IMPLEMENTATION OF THE LIFE CYCLE



PUBLIC PROCUREMENT FOR **ENERGY SERVICES** A draft resolution that reduced the duration of the energy service

procurement procedure to 2-3 months, instead of 6-10 months, has been prepared. The resolution was approved and adopted by the CMU. Under the new procedure, 30+ tenders were already announced, and 1 agreement for UAH 35+ mln was concluded.

OF EDUCATIONAL AREAS FOR PUBLIC **PROCUREMENT** In cooperation with the Mineconomy, we prepared and registered in the VRU amendments to draft law No. 6013 for the second reading, aimed at mandatory reorganization of SOEs and recommended reorganization of MEs into LLCs or JSCs.


DEVELOPMENT OF THE CONCEPT OF APPROACH TO THE SELECTION



CRITICAL TO THE FUNCTIONING OF THE ECONOMY We assisted the Mineconomy in developing criteria for determining enterprises critical to the functioning of the economy. Methodological recommendations on reserving persons subject to military service for business have been developed. The material is available by the link.

SUBSTITUTION An analytical review of sanctions restrictions on russian pig iron and ferrous metal ores for the Mineconomy has been prepared.

LAUNCH OF TRACKING OF THE INDUSTRIAL PARK REGISTRATION



We developed and implemented an online tracker to monitor the registration process for industrial parks, which includes 13 to 16 stages of consideration by the authorities within 45 days. Now, applicants can independently track the status of their documents
