COMMUNICATION FROM UKRAINE

Revision

The following communication, dated 3 August 2021, is being circulated at the request of the delegation of Ukraine.

Ukraine hereby updates the notifications previously made on articles 1.4, 10.6.2 and 12.2.2 of the Agreement on Trade Facilitation in document G/TFA/N/UKR/3. In addition, Ukraine also notifies information on article 10.4.3.

As far as updated information on articles 1.4, 10.6.2 and 12.2.2 is concerned, all information is new except for the input previously notified on article 10.6.2.

The Single Window for International Trade (SW) is managed by the State Customs Service of Ukraine and available for registered traders and customs brokers through using digital keys.

This platform allows to submit all documents which are needed for customs clearance, including most of the permission documents, which are issued by other government agencies through the SW.
