The NSC-2.2 CONTRACT No. 1 forms a part of the continuation of NSC-2.1 covering the portion of NSC-2.2 pipeline between the Masama Wellfields and Mmamashia WTW, and will convey raw water southwards to Greater Gaborone from the Masama Wellfields as well as from impoundments located in the NE region of Botswana.
