AMENDMENTS  
to the Resolution of the Cabinet of Ministers of Ukraine  
of 20 March 2020 No. 225

1. Procedure for procurement of supplies, works and services necessary for taking measures aimed to prevent occurrence and spread, localize and liquidate the outbreak, epidemics and pandemics of the coronavirus disease (COVID-19) within Ukraine, as approved by the said Resolution, shall be amended as follows:

PROCEDURE  
for procurement of supplies, works and services necessary for taking measures  
aimed to prevent occurrence and spread, localize and liquidate the outbreak,  
epidemics and pandemics of the coronavirus disease (COVID-19) within  
Ukraine

1. This Procedure sets out the rules of procurement of supplies, works and services necessary for taking measures aimed to prevent occurrence and spread, localize and liquidate the outbreak, epidemics and pandemics of the coronavirus disease (COVID-19) within Ukraine.

2. For the purposes of this Procedure, the terms shall have the following meaning:

‘procurement’ means purchase of supplies, works and services by a procuring entity, necessary for taking measures aimed to prevent occurrence and spread, localize and liquidate the outbreak, epidemics and pandemics of the coronavirus disease (COVID-19) within COVID-19, according to the rules set out in this Procedure;

‘person authorized by a procuring entity to make procurements’ (hereinafter referred to as ‘authorized person’) means an officer (official) of a procuring entity designated by it as a person responsible for organizing and holding procurements.

Other terms used in this Resolution shall have a meaning defined in the Law of Ukraine “On Public Procurement” and other legal and normative acts.

3. In making procurements, a procuring entity and its authorized persons shall be guided by the Constitution and laws of Ukraine, decrees of the President of Ukraine and resolutions of the Verkhovna Rada of Ukraine adopted pursuant to the Constitution and laws of Ukraine, acts of the Cabinet of Ministers of Ukraine and other legislative acts.

4. The following principles shall apply to procurements:

fair competition among tenderers;

best value for money, efficiency and proportionality;

openness and transparency in organizing and holding of procurements;

non-discrimination and equal treatment of tenderers;

objective and unbiased award of contracts;

prevention of corruption offenses.

5. Procurements shall be planned by a procuring entity depending on the existing need for supplies, works and services.

6. An authorized person shall:

plan procurements and enter information to the annual procurement plan in the e-procurement system, in particular technical, qualitative and other characteristics of the procurement item;

organize and hold procurements. A procuring entity may establish, at its own discretion, integrity and reliability criteria for a supplier to award a procurement contract;

ensure preparing, approval and keeping of relevant procurement documents;

ensure publication, in the e-procurement system, of information required to comply with Section I, points 8 and 9, of the Law of Ukraine of 17 March 2020 No. 530-IX “On Amending Certain Legislative Acts of Ukraine Aimed to Prevent Occurrence and Spread of the Coronavirus Disease (COVID-19)”;

take other actions provided for in this Law.

All decisions of the authorized person shall be documented in the form of minutes indicating the date of the decision.”.
